Kevin McAvev is a director at Manatt Health Strategies, where he advises states on how to develop health data capacity in their agencies and markets to advance policy, program, and regulatory goals. Kevin specializes in developing comprehensive data strategies for state Medicaid, social services, public health, and health insurance agencies and in designing philanthropic investment strategies that catalyze market change. Kevin is widely published on the topics of health care data, data exchange, and data use innovations.

Prior to joining Manatt, Kevin was associate director of analytics at Massachusetts' Center for Health Information and Analysis (CHIA), where he helped design and implement the nation's first state cost growth benchmarking program and bring the state's All-Payer Claims Database (APCD) online for ongoing analytic use. He was one of the state's first APCD programmers and served as its business representative in the cross-state drafting of the first national APCD Common Data Layout.

Kevin serves on the board of directors of the National Association of Health Data Organizations (NAHDO) and the Association of Public Data Users.

Don Beyer U.S. Representative Virginia's 8th District

Biography

Don Beyer is serving his fourth term as the U.S. Representative from Virginia's 8th District, representing Arlington, Alexandria, Falls Church, and parts of Fairfax County. He serves as chairman of Congress' Joint Economic Committee, on the House Committee on Ways and Means, and on the House Committee on Science, Space and Technology, where he chairs the Space Subcommittee. He is co-chair of the New Democrat Coalition's Climate Change Task Force.

Don was Lieutenant Governor of Virginia from 1990 to 1998. His signature work as lieutenant governor included advocacy for Virginians with disabilities and ensuring protections for Virginia's most vulnerable populations as the commonwealth reformed its welfare system in the mid-1990s. he was Virginia's Democratic nominee for governor in 1997.

After leaving office, Don spent 14 years as chair of Jobs for Virginia Graduates, a highly successful high school dropout prevention program, and was active for a decade on the board of the D.C. Campaign to Prevent Teen Pregnancy. As chair of the Virginia Economic Recovery Commission, he helped pass permanent pro-business reforms and was co-founder of the Northern Virginia Technology Council.

President Obama nominated Don in 2009 to serve as ambassador to Switzerland and Liechtenstein. He used his position to advocate for stricter sanctions to compel Iran to begin nuclear disarmament discussions. As ambassador. Don was integral to U.S. Department of Justice efforts to halt the abuses of Swiss bank secrecy by wealthy Americans.

Don has spent four decades building his family business in Northern Virginia after having held a summer job at a car dealership in 1974. He is a graduate of Williams College and Gonzaga College High School in Washington, D.C. He was named a Presidential Scholar by President Lyndon Johnson.

Don has four children and two grandchildren. He and his wife, Megan, live in Alexandria, Virginia.

She was a post-doctoral fellow at Princeton University's Office of Population Research at the Woodrow Wilson School. Katherine has taught history, public policy, and biostatistics in various settings. She frequently speaks and writes about health insurance and other healthcare topics. She is also an active researcher, and has authored numerous articles in the peer reviewed literature.

Biography

Nancy De Lew is the Associate Deputy Assistant Secretary for Health Policy in the Office of the Assistant Secretary for Planning and Evaluation at HHS. She serves as the senior career official in the Office of Health Policy where she leads a team of people who apply their skills in policy development, strategic planning, research, and evaluation to some of the Department's most challenging health policy problems. She provides executive leadership and coordination on a broad range of health care financing, coverage, access, public health, and quality issues.

Prior to her service in ASPE, Nancy held a variety of management positions in CMS including directing the policy team in the Office of Health Insurance Exchanges, serving as Deputy Director of the CMS Office of Legislation, and serving as Director of the Special Analysis Staff. Karynlee Harrington is executive director of the Maine Health Data Organization (MHDO) and the Maine Quality Forum (MQF) — both independent agencies that are part of Maine's state government — responsible for health care data collection and improving health care quality, respectively. The agencies are required to collaborate on promoting the transparency of health care costs and quality information in Maine. Under Karynlee's leadership, in 2014 the MHDO was awarded a \$3 million grant to build the state's health care cost and quality transparency website, CompareMaine. CompareMaine has been recognized nationally as one of the most comprehensive and consumerfriendly health care transparency websites in the country.

Prior to her current role. Karvnlee served as Executive Director of the state's Dirigo Health Agency, where she led the team in developing, implementing, and securing financing for the state's subsidized health insurance program designed for small business, the self-employed, and individuals. The program covered over 700 small business and self-employed individuals and provided access to lower cost health insurance to over 40,000 Mainers before it ended and transitioned its membership to the federal exchange.

Karynlee started her career working in the insurance industry. When she left in 2003, she was vice president of sales and customer support for CIGNA HealthCare of Maine and New Hampshire, where she worked with many of the largest employers in the state of Maine. She is currently chair of the board of directors for the National Association of Health Data Organizations and has over 20 years' experience working in an executive role in health care. She earned her BS from the University of New Hampshire in health management and policy.

Michael Chernew, PhD, is the Leonard D. Schaeffer Professor of Health Care Policy and director of the Healthcare Markets and Regulation (HMR) Lab in the Department of Health Care Policy at Harvard Medical School, Dr. Chernew's research examines several areas related to improving the health care system including studies of novel benefit designs, Medicare Advantage, alternative payment models, low-value care, and the causes and consequences of rising health care spending.

Dr. Chernew is currently serving as Chair of the Medicare Payment Advisory Commission (MedPAC) while previously serving as vice chair 2012-2014 and as a member 2008-2012. In 2000, 2004, and 2010, he served on technical advisory panels for the Centers for Medicare & Medicaid Services (CMS) that reviewed the assumptions used by Medicare actuaries to assess the financial status of Medicare trust funds. He is a member of the Congressional Budget Office's Panel of Health Advisors and vice chair of the Massachusetts Health Connector Board, Dr. Chernew is a member of the National Academy of Sciences, a research associate at the National Bureau of Economic Research, and a senior visiting fellow at MITRE. He is currently a co-editor of the American Journal of Managed Care.

Dr. Chernew earned his undergraduate degree from the University of Pennsylvania and his PhD in economics from Stanford University. In 1998, he was awarded the John D. Thompson Prize for Young Investigators by the Association of University Programs in Public Health. In 1999, he received the Alice S.
