MEDICAID MANAGED CARE 2004 QUALITY UPDATE

This report was prepared by the PHSP Coalition based on findings in the 2004 Managed Care Plan Performance Report produced by the New York State Department of Health. The PHSP Coalition is an association of 15 health plans serving nearly 1.8 million Medicaid, Family Health Plus and Child Health Plus beneficiaries throughout New York State. Coalition plans are sponsored by public and nonprofit hospitals, community health centers and physicians. The majority of Coalition plans have participated in New York's Medicaid managed care program for more than a decade.

MANAGED CARE CONTINUES TO IMPROVE CARE FOR MEDICAID BENEFICIARIES

In 1995, Governor Pataki announced plans to require most New York Medicaid managed care beneficiaries to enroll in managed care plans. Ten years later, the results are clearer than ever: Medicaid managed care has increased access to high-quality health care providers for Medicaid beneficiaries and has improved the quality of care compared to the fee-for-service system.


Almost two million Medicaid beneficiaries receive their care through managed care plans, as do 700,000 Family Health Plus and Child Health Plus beneficiaries. It has taken almost two decades to build a sound managed care infrastructure and there is still more to be done. However, the results today are compelling. New York's Medicaid managed care plans have improved care over the fee-for-service system, both year-to-year and as compared to national benchmarks. We have seen demonstrable improvements in quality measures such as:

- Management of asthma medications,
- Cervical and breast cancer screening,
- Management of diabetes,
- Post-discharge follow-up for mentally ill patients, and
- Access to Board Certified providers.

Significantly, both analyses by the New York State Coalition of PHSPs (PHSP Coalition) as well as national organizations show that managed care plans have increased the quality of care for their members while keeping Medicaid cost growth below that of fee-for-service.¹








Medicaid managed care beneficiaries in New York have access to Board Certified providers at rates which exceed national averages even for commercial plans in the fields of primary and pediatric care.






